So it was murder!! I needed to round up the most likely suspects from my initial interviews and pull them in for a follow up now the deed had taken place.

Second Interviews with Suspects: Conducted straight after the murder:

Maggie Thompson

Jack Schmitt: Maggie, I need you to account for your whereabouts between 2 PM and 4 PM on the day of the murder.

#### Lord Sebastian Pembroke

Jack Schmitt: Sebastian, where were you between 2 PM and 4 PM on the day of the murder?

Jack Schmitt: Did anyone leave the room during the period after?

Sebastian Pembroke: People came and went, but I remained at the table. My focus was on the game. I did notice a steward come in to refresh our drinks a couple of times. It was a lively atmosphere, despite the tension that always accompanies a high-stakes game.

Jack Schmitt: And you stayed there until 4 PM?

Sebastian Pembroke: Yes, I did. In fact, I think I stayed a bit past 4 PM. The game was too engaging to leave. You can verify my presence with the other players. They'll tell you I was there the whole time, either playing cards or sipping my drink.

#### Charles Blackwood

Jack Schmitt: Mr. Blackwood, can you account for your time between 2 PM and 4 PM on the day of the murder?

Charles Blackwood: Of course, Detective. My day was quite structured, as always. After lunch, I returned to my cabin to work on some business matters. Evelyn Whitfield: Detective, I spent that time in my cabin. The recent events have been quite stressful, and I needed some time alone to collect my thoughts. After lunch, I returned to my room and tried to rest.

#### Nita Redfeather

Jack Schmitt: Nita, I need to know your whereabouts between 2 PM and 4 PM on the day of the murder.

Nita Redfeather: Detective, I spent that time in the observation lounge. It's a quiet place where I can reflect and find some peace. The events on this ship have been unsettling, and I needed to center myself.

Jack Schmitt: Can you tell me more about what you were doing in the lounge?

Nita Redfeather: I was meditating, watching the ocean. The rhythm of the waves helps calm my thoughts. I also brought a book with me—something to distract my mind. I prefer to keep to myself during these times. It's a way to find balance amid the chaos.

Jack Schmitt: Did anyone see you there?

Nita Redfeather: A few passengers might have seen me. I recall seeing some familiar faces, but I didn't engage in conversation. I was focused on my meditation and reading. The observation lounge is usually a quiet place, perfect for solitude.

Jack Schmitt: And you stayed there until 4 PM?

Nita Redfeather: Yes, I did. I remained there, lost in my thoughts and the gentle sway of the ship. It wasn't until the bell chimed 4 PM that I decided to return to my cabin. The tranquility of the lounge was a welcome escape from the tension on board.

Henry Whitfield (Posthumous)

Jack Schmitt: We can't question Henry, but we need to piece together his movements. Any insights, Captain?

I greeted several passengers and engaged in brief conversations. I made my way back to the bridge by 3:30 PM to check in with the first officer again before heading to my cabin.

Jack Schmitt: Did anyone accompany you during your rounds?

Captain Radgrove: No, I usually conduct my rounds alone. It allows me to observe without drawing too much attention. However, my first officer can confirm my presence on the bridge during the times I mentioned.

Jack Schmitt: And after 4 PM?

Captain Radgrove: After my walk, I returned to my cabin for a brief moment to collect some papers. I then headed back to the bridge to finalize the evening's itinerary. It was shortly after that we received the alarm about Henry Whitfield.



Tribe Forcibly Removed from Ancestral Land

In a controversial and heated move, the Lakota Tribe was forcibly removed from their ancestral lands yesterday by order of industrial magnate Richard Whitfield, Sr. The removal was met with significant resistance from the tribe, who have occupied the land for generations.
